Employment related Residence Permits

Dependent Employment

(qualified and unqualified workforce)

- Employer's application: Required
- Visa requirement: National Entry Visa (*type D*)
- Duration: 3 years
- RP Renewal: Applicable (*5 years*)
- Family reunification: Applicable after 2 years of the employee residing in Greece

Highly Qualified Personnel

(EU Blue Card)

- Employer's application: Required (*under conditions*)
- Visa requirement: National Entry Visa (*type D*) or Uniform Entry Visa or Valid RP or Visa exemption regime
- Duration: 3 years
- RP Renewal: Applicable (*3 years*)
- Family Reunification: Direct right granted to family members (*without prior approval procedure*)

Seasonal Work in the Tourism Sector

- Employer's application: Required
- Visa requirement: National Entry Visa (*Type D*) or Uniform short-term Entry Visa (*Schengen*) for multiple entries
- Duration: Up to 9 months per 12-month period, with extension up to 5 years
- RP Renewal: Applicable (*up to 5 years*), provided that the total duration of the residence does not exceed a total of 10 years

Intra-Corporate Transfer for managers, qualified employees and trainees

The host entity and the undertaking established in a third country should belong to the same company or group of companies

- Employer's application: Required
- Visa requirement: National Entry Visa (*type D*)
- Duration: Up to 3 years for managers and qualified employees and up to 1 year for trainees
- RP Renewal: Applicable (*3 years for managers and qualified employees and 1 year for trainees*)
- Family Reunification: Direct right granted to family members (*without prior approval procedure*)



Special Purpose Employment

- Eligibility:
 - Managers, operational and technical executives of companies engaged in marine research, drilling and extraction of hydrocarbons
 - Employees and legal representatives in commercial-industrial companies (*L. 89/1967*) and shipping companies
 - Technicians in mines or industries under the terms of *L. 448/1968*
 - Executives of investment schemes of a strategic investment vehicle
- Employer's application: Required
- Visa requirement: National Entry Visa (*type D*)
- Duration: 3 years
- RP Renewal: Applicable (*3 years*)
- Family Reunification: Direct right granted to family members (*without prior approval procedure*)

Employment under Public or Strategic Investment Projects

Entities implementing **public or strategic investment projects of significant economic, social, or national importance** may submit an application under the Recall/Invitation procedure for the admission of up to 500 third-country nationals per project. This mechanism is designed to facilitate the timely execution and operation of large-scale investments.

Following approval, third-country nationals enter Greece with a visa or, where applicable, under national visa exemption, and must apply for an E.4 residence permit before the expiry of their entry status. Relevant visa applications are examined on a priority basis by Greek consular authorities.

- Eligibility:

The application is examined on a **priority basis** and must include: A valid employment contract of at least six (6) months in Greece, provided that the remuneration of the third-country national is at least equal to the monthly earnings of the unskilled employee, as determined each time, for the years 2025, 2026 and 2027, of the Labor Law Code
- Certification from the competent Ministry confirming the strategic or public character of the investment
- Visa requirement: National Entry Visa
- Duration: 3 years
- RP Renewal: Applicable (*5 years*)

Public Interest

Specifically in the fields of foreign policy, defense, public security, economy and development, investment, education and culture (*approval of the competent public authority required*)

- Employer's application: N/A
- Visa requirement: National Entry Visa (*type D*) or Uniform Entry Visa, where required, or Visa exemption regime
- Duration: 3 years
- RP Renewal: Applicable (*3 years*)
 - Family Reunification: Direct right granted to family members (*without prior approval procedure*)

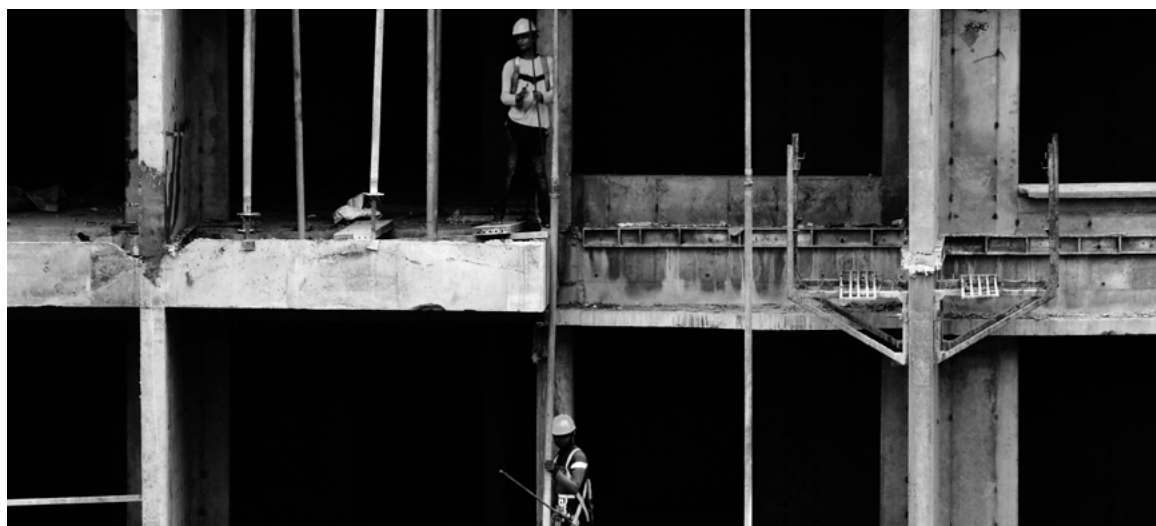


Investment related Residence Permits

Investment through Establishment and Operation of a Business

(with positive impact on Greek development and economy)

- Investment Requirement: >500.000€
- Visa requirement: National Entry Visa (*type D*), unless a valid Entry Visa or valid RP or certificate of application is held
- Duration: 5 years
- RP Renewal: Applicable (*5 years*), provided that the investment continues to be carried out or continues to operate after its completion
- Family Reunification: Direct right granted to family members (*without prior approval procedure*)



Executives of Companies, subsidiaries of foreign companies established in Greece with commercial activity

- Eligibility:
 - Holders of at least 33% of a domestic company with a minimum cash investment of €500,000 in registered shares, or holders of shares in a domestic company traded on Greek regulated markets or multilateral trading facilities with securities totaling €500,000 in nominal value
 - BoD members, legal representatives, or administrators of domestic companies, and legal representatives of foreign companies branches operating legally in Greece with assets or turnover of at least €4,000,000 in the last fiscal period
- Visa requirement: National Entry Visa (*type D*), unless a valid Entry Visa or valid RP or certificate of application is held
- Duration: 5 years
- RP Renewal: Applicable (*5 years*), provided that the investment continues to be carried out or continues to operate after its completion
- Family Reunification: Direct right granted to family members (*without prior approval procedure*)

Strategic investors

- Eligibility:
 - BoD members and/or shareholders of a foreign legal entity that operates as a strategic investment vehicle
 - Visa requirement: National Entry Visa (*type D*), unless a valid Entry Visa or valid RP or certificate of application is held
 - Duration: 5 years
 - RP Renewal: Applicable (*5 years*), provided that the investment continues to be carried out or continues to operate after its completion
 - Family Reunification: Direct right granted to family members (*without prior approval procedure*)

Expat Tax Regime

In addition to the immigration process, employees of a **Greek company** or a Greek branch of a foreign company, may also apply for a favorable tax regime that grants **an exemption from income tax on 50% of their employment income**.

- Eligibility:
 - Not Greek tax residents for 5 out of the 6 years before residing in Greece
 - Transfer their tax residence to Greece from a member state of the EU or the EEA or a country with which Greece has a valid administrative cooperation agreement on tax issues
 - Intention to stay in Greece for at **least 2 years**.
